I/We are aware of the risks and hazards that are connected with traveling on the road to and from such events that from time to time will be available to me/us by Alpine SoCal. I hereby elect to voluntarily participate in activities that may be available to me as a member of Alpine SoCal.

I/We further hereby agree TO INDEMNIFY AND HOLD HARMLESS THE RELEASEES from any loss, liability, damage or costs, including court costs and attorney fees, which may arise from my participation in the driving to and from such activities.
